Showing leadership and dedication, he co-founded Mayors Against Illegal Guns



Women Against Gun Violence is pleased to announce Mayor Michael Bloomberg as the recipient of our Courageous Leadership Award to be presented in 2012.

Michael R. Bloomberg is the 108th Mayor of the City of New York. He was first elected in November 2001, two months after the terrorist attacks on 9/11, a time when many believed that crime would return, businesses would flee, and New York might never recover. Instead, through hundreds of innovative new policies and initiatives, Mayor Bloomberg has made New York City safer, stronger, and greener than ever.

Bloomberg's belief that America's mayors and business leaders can help effect change in Washington has led him to launch national bi-partisan coalitions to combat illegal guns, reform immigration, and invest in infrastructure.

In 2006, with an initial group of 15 mayors, Mayor Bloomberg co-founded Mayors Against Illegal Guns, dedicated to making America's cities safer by cracking down on illegal guns. The coalition's bipartisan ranks have grown to more than 500 mayors from more than 40 states embracing the principle that mayors have a responsibility to protect their communities by holding gun offenders and irresponsible gun dealers accountable, demanding access to trace data that is critical to law enforcement efforts to combat illegal gun trafficking, and working with legislators to fix gaps, weaknesses and loopholes in the law that make it far too easy for criminals and other prohibited purchasers to get guns.

We applaud Mayor Bloomberg for his nationwide leadership and commitment to keeping our communities safe!

LEGISLATIVE *UPDATE*

The fight for critical gun legislation in California has recently witnessed significant success with the adoption of three State bills signed into law by Governor Jerry Brown. We are proud to see the passage of AB144, AB809, and SB819 as California positions itself as a state that is serious about effectuating policies that promote public safety and protect our communities from the dangers of gun violence.

We are grateful for the tenacious support of our partner organizations, our State legislators, Governor Jerry Brown and you, our activists, who have all enabled these legislative victories!

AB144, Prohibiting Open Carrying of Handguns in Public Places

California becomes the fifth state to make it illegal to openly tote handguns.

Beginning in 2012, the open carrying of unloaded handguns in public spaces will be treated as a misdemeanor, and violators of the law will accrue a fine of up to \$1,000 and up to six months in county jail. With this announcement, California became the fifth state to make it illegal to openly tote handguns.

Previously, California law allowed individuals the right to carry unloaded handguns openly and separately from their ammunition. Starting in early 2010, groups across the state aggressively asserted this right by informally gathering en masse at Starbucks coffee shops, and other public dining establishments while flaunting their unloaded weapons. The close collaborations between WAGV and other gun violence prevention organizations statewide means we can dine in public with our families without experiencing intimidation from gun-toting individuals carrying ammunition just inches from their unloaded weapons.

Deemed as dangerous by law enforcement officials statewide, the practice of open carry was regarded as a major hindrance to public safety because law enforcement personnel were faced with the formidable task of determining which individuals were packing loaded or unloaded heat.

SB819, Authorizing Use of Fees for Enforcement of Firearms Prohibitions

Another important California measure WAGV is pleased to see pass is SB819. This bill will devote more funds and resources to keep guns out of the hands of prohibited owners. These firearms in question are guns that were purchased legally but whose owners are no longer allowed to have them due to criminal activity or mental illness. When you take into consideration that more than 18,000 Californians are registered gun owners, and that 15-20 names are added each day to the "prohibited owners" list, this new law will ensure that cross-checks between databases are conducted.

FEDERAL LEGISLATION

HR822, National Right-to-Carry Reciprocity Act

With Brown's signature on AB144, AB809 and SB819, California's progress in gun legislation is proving to be a far digression from the grim trend toward lax gun regulations other states are following. Despite our recent triumphs, a new Federal bill under consideration, HR822, the National Right-to-Carry Reciprocity Act, would force every state to honor and comply with every other state's permit to carry a concealed gun – no matter how lax the other state's standards. As a result, it would allow individuals to carry concealed, loaded weapons in public in states across America, even if the individuals do not meet the minimum public safety standards many states already have in place – such as safety training, age, or a clean arrest record.

In September, a broad coalition of mayors,

AB809, Requiring Long Gun Record Retention

Also effective in January 2012, AB809 will help increase public safety and assist law enforcement in solving gun related crimes by requiring the Department of Justice to retain copies of sales records for rifles and shotguns, as it currently does for handgun records. This new requirement on long gun records keeping arrives as a welcome and necessary change to our state's books, as information of people purchasing long guns was previously required to be destroyed instead of being entered into the Automated Firearm System (AFS). With

The Public Health Approach to Firearms and Firearm Violence

Public Health is charged with protecting the community's health. Traditionally public health epidemiology has focused on the more familiar themes of protecting food, water, and people from infectious and chronic diseases. However, the leading causes of death and disability have shifted during the past three decades from the more traditional themes, to Injury and Violence. These have emerged as the leading causes of death and disability for the population less than 45 years of age. As in traditional public health investigations and prevention strategies, eliminating the disease vector, as in malaria, has proven to be the most efficacious strategy for reducing and controlling an epidemic. The vector of this epidemic is clear, it is the firearm and as in other public health epidemics where the vector is known, we must control the vector in order to prevent

the ongoing epidemic from continuing to spread.

Statistics confirm that gun violence is indeed the epidemic of our time. In the past ten years it has killed more young people than cancer, heart disease or AIDs. And what's more it does act like a contagious disease. In our neighborhoods, when a young person is shot it often prompts a retaliatory shooting, which then spreads to others. Gun violence is contagious, and the public health approach working with organizations like WAGV and other advocacy organizations is critical to controlling and eventually eliminating this epidemic. Prevention, before anything happens is our goal and educating the public, health care providers, and policy makers is critical if we are to win the battle against what I consider to be the greatest public health epidemic of our time.

police organizations, domestic violence experts, prosecutors and 45,000 Americans, announced a national effort to defeat this Federal legislation. The campaign – www.OurLivesOurLaws – was launched by Mayors Against Illegal Guns, a bipartisan coalition of more than 600 Republican, Independent and Democratic mayors.

By overriding standards set by other states, this legislation creates a nationwide lowest-common-denominator approach to public safety laws. The bill also threatens the safety of police officers by making it far more difficult to distinguish between legal and illegal firearm possession. The bill fails to establish a national database that would make it possible for officers to verify an out-of-state permit, leaving them without any reliable way to be certain that someone with a loaded gun and one of dozens of types of out-of state permits is actually obeying the law.

As we go to print, HR822 passed out of the House Judiciary Committee on party lines except for Representative Dan Lungren, (R-CA) who voted "no". Thank you for all your

calls to his office asking for his no vote. It worked!

HR308/S32 –Stuck in Committee

Shortly after 19 people, including Rep. Gabrielle Giffords, were shot outside a Tucson, Arizona grocery store with a handgun equipped with a large capacity ammunition magazine, Rep. Carolyn McCarthy and Sen. Frank Lautenberg introduced HR308/S32, the Large Capacity Ammunition Feeding Device Act, in the 112th Congress, to prohibit civilian possession of these military style magazines. The Act makes it unlawful for a person to possess a large capacity ammunition magazine unless it was lawfully possessed before the bill was enacted. It also prohibits the transfer or sale of large capacity ammunition magazines. Exemptions are made for active and retired law enforcement, for certain federal and state departments and agencies, and allows manufacture, transfer, or possession of large capacity magazines for authorized testing or experimentation.

Both these bills are in the first step of the legislative process; introduced bills and

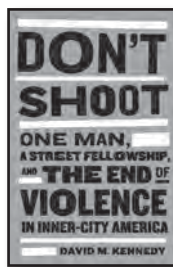

resolutions first go to committees that deliberate, investigate and revise them before they go to general debate. On February 7, 2011 the House Committee on the Judiciary referred HR308 to the Subcommittee on Crime, Terrorism, and Homeland Security.

Don't Shoot

One Man, A Street Fellowship, and the End of Violence in Inner-City America
 By David M. Kennedy
 (Bloomsbury USA, Hardcover, 9781608192649, 320pp.)

Gang and drug-related inner-city violence, with its attendant epidemic of incarceration, is the defining crime problem in our country. In some neighborhoods in America, one out of every two hundred young black men is shot to death every year, and few initiatives of government and law enforcement have made much difference. But when



Kennedy found that all parties misunderstood each other, caught in a spiral of racialized anger and distrust.

David Kennedy, a self-taught and then-unknown criminologist, engineered the “Boston Miracle” in the mid-1990s, he pointed the way toward what few had imagined: a solution.

Don't Shoot tells the story of Kennedy's long journey. Riding with beat cops, hanging with gang members, and stoop-sitting with grandmothers, Kennedy found that all parties misunderstood each other, caught

in a spiral of racialized anger and distrust. He envisioned an approach in which everyone – gang members, cops, and community members – comes together in what is essentially a huge intervention. Offenders are told that the violence must stop, that even the cops want them to

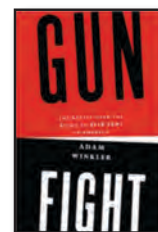
stay alive and out of prison, and that even their families support swift law enforcement if the violence continues. In city after city, the same miracle has followed: violence plummets, drug markets dry up, and the relationship between the police and the community is reset.

This book chronicles a paradigm shift in how we address one of America's most shameful social problems. A riveting, page-turning read, it combines the street vérité of *The Wire*, the social science of *Gang Leader for a Day*, and the moral urgency and personal journey of *Fist Stick Knife Gun*. But unlike anybody else, Kennedy shows that there could be an end in sight.

In *Gunfight: The Battle over the Right to Bear Arms in America*, Adam Winkler weaves together the dramatic story of a landmark Supreme Court case and the remarkable hidden history of guns in America. He shows how gun rights and gun control have coexisted since our earliest days – and how efforts to balance the two have profoundly shaped the nation in fascinating and unexpected ways.



Using the lessons of this history, *Gunfight* maps out a way to break the current political stalemate on guns and restore reason to the gun debate.

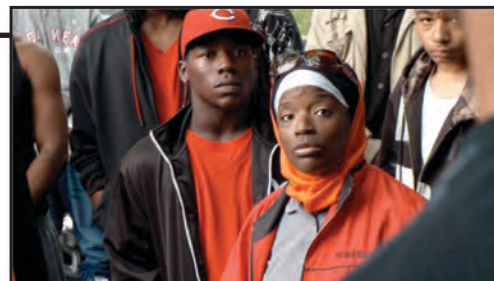

THE INTERRUPTERS tells the moving and surprising story of three dedicated individuals who try to protect their Chicago communities from the violence they themselves once employed. These “violence interrupters” (their job title) – who have credibility on the street because of their own personal histories – intervene in conflicts before the incidents explode into violence. Their work and their insights are informed by their own journeys, which, as each of them point out, defy easy characterization.

Their work is fraught with moral quandaries. They have to step between adversaries, often people they know. They need to acknowledge people's grievances while simultaneously pulling them back from acting on them. And on occasion, they find themselves using the very threat of violence to defuse an altercation. As they venture into their communities, they

confront the importance of family, the noxious nature of poverty, and the place of race. And they do it with incredible candor and directness.

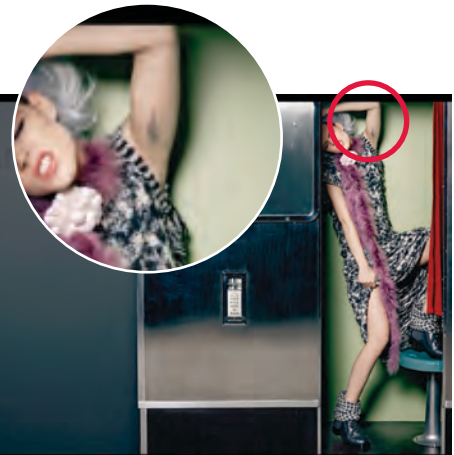


Shot over the course of a year, THE INTERRUPTERS captures a period in Chicago when it became a national symbol for the violence in our cities. During that period, the city was besieged by high-profile incidents, most notably the brutal beating death of Derrion Albert.

The “violence interrupters” work for an innovative organization, CeaseFire, which is the brainchild of epidemiologist Gary Slutkin who for ten years battled the spread of cholera and AIDS in Africa. Slutkin believes that the spread of violence mimics that of infectious diseases, and so the treatment should be similar: go after the most infected, and stop the infection at its source.
